1. Bowlers with 21 games in 2008-09 must use highest league (s) average as end of 2008-09 season. All others excluded. All averages must be USBC sanctioned.
2. If current year average (as of April 15, 2010) is 10 or more pins higher than previous yearbook average based on 21 or more games, current average must be used.
3. Prize money returned 100%, but no entry fees will be returned. A minimum of one prize for each 10 entries is guaranteed.
4. No bowler shall be permitted to enter or bowl more than once.
5. In case of substitution, the team must bowl in original teams classification.
6. Weston Lanes is the sole legislator of tournament within frame of USBC.
7. Rule 7 USBC Rule 319 A, C, D and E apply
8. YABA rules prohibit any member from participating in any tournament where awards or prizes are given.
9. Bowlers must reside or league bowl in the following counties: Adams, Clark, Forest, Langlade, Lincoln, Marathon, Oneida, Portage, Price, Rusk, Shawano, Taylor, Vilas, Waupaca, Waushara, and Wood.
10. Bowlers should be familiar with the average adjustment requirements of USBC Rule 319E.
11. All entrants must have USBC membership card or pay \$5.00 participation fee.
12. Tournament Administrator Reserves the right to re-rate any bowler.
